Hintergrund

Lizenzen, die zu einer Nutzung von Geutebrück Software berechtigen, werden für einen dedizierte Hardware aktiviert und sind nur auf dieser nutzbar. D.h. im Falle eines Austausches der Hardware oder Teilen der Hardware kann es nötig sein, die Aktivierungen für dieses System zu widerrufen, sodass die Lizenzen anschließend nach dem Hardware-Austausch erneut aktiviert werden können.

Der Geutebrück Lizenzmanager verfügt über eine LockingID, durch die das System bei der Aktivierung von Lizenzen eindeutig identifiziert wird. Alle Aktivierungen, die für dieses System durchgeführt wurden, lassen sich anhand dieser LockingID im Lizenzportal von Geutebrück auffinden. Weiterhin lassen sich die Aktivierungen auch über die ID eines zugewiesenen Entitlements, in dem die Lizenz enthalten ist, suchen.

- **Das Upgrade-Kit dient der Aufrüstung von Windows 10 auf Windows 11.**
Das Upgrade-Kit ermöglicht es Ihnen, die neueste GEUTEBRÜCK Videoüberwachungstechnik und Videomanagement-Software einzusetzen.
- **Sichern Sie alle Setups / Passwörter / Datenbanken (alle Daten) Ihres Systems! (Windows, G-Sim, G-Core,).** Für eventuell resultierende Kosten für eine erneute Parametrierung des Systems in der Kundenanwendung wird keine Haftung seitens GEUTEBRÜCK übernommen.
- **Nach dem Upgrade muss der Windows 10 Aufkleber entfernt und der neue Windows 11 Lizenzaufkleber am Gerät angebracht werden.**

Vorgehensweise

Auswahl – LockingID vs. Entitlement

Grundsätzlich gibt es zwei Wege, diejenigen Lizenzen, die für den Lizenzmanager einer (auszutauschenden) Hardware-Konfiguration aktiviert wurden, im Lizenzportal von Geutebrück aufzufinden, um dort einen Widerruf (Revocation) der Aktivierung(en) vorzunehmen.

Die erste Möglichkeit ist die Suche über die Entitlement ID.

Hierzu wird der Geutebrück Lizenzmanager geöffnet und eine Lizenz ausgeklappt, für die eine Revocation vorgenommen werden soll. Die Entitlement ID kann hier in die Zwischenablage kopiert werden, damit sie anschließend zur Suche im Lizenzportal von Geutebrück eingefügt werden kann.

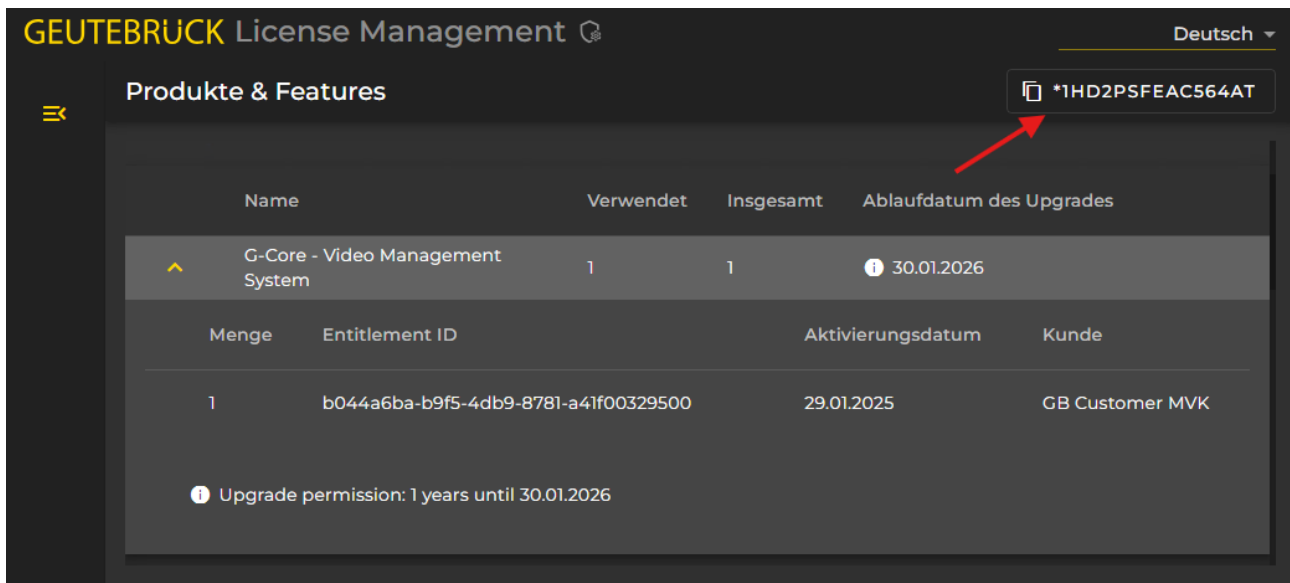

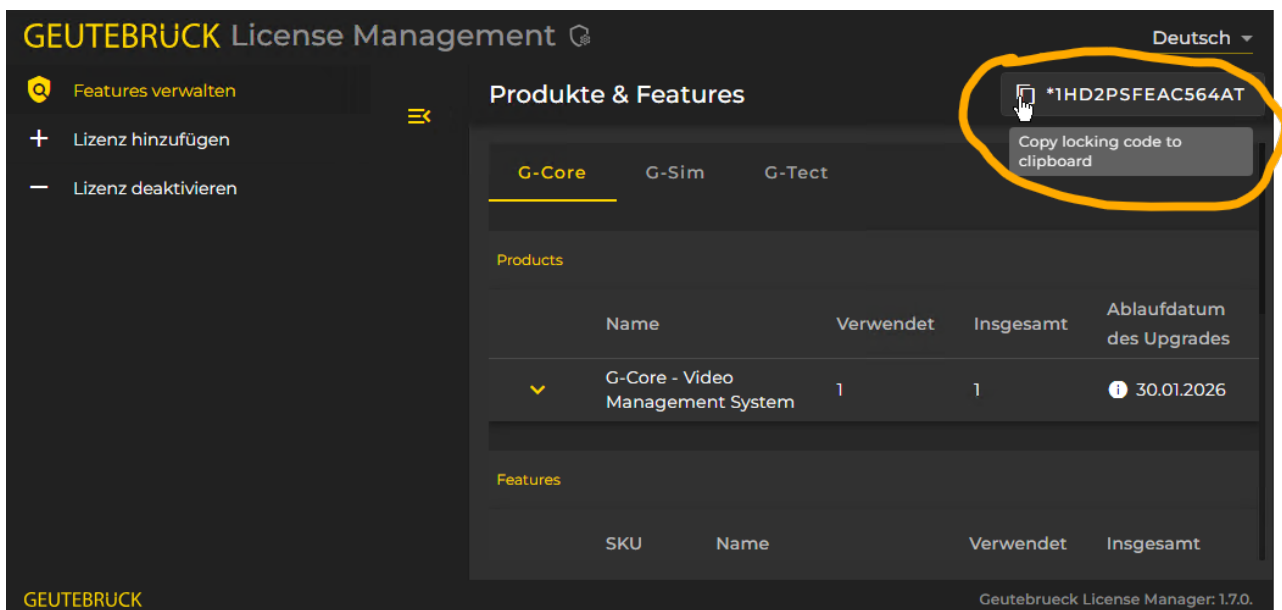
Wenn die Revocation für ein komplettes System – und nicht nur für einzelne Lizenzen – durchgeführt werden muss, empfiehlt es sich, anstelle der Entitlement ID die Locking ID zur Suche im Lizenzportal zu verwenden.



Der Vorteil einer Suche über die LockingID ist, dass eine Suche über diesen Weg im Lizenzportal zu einem Überblick über alle Aktivierungen, die für diesen Lizenzmanager vorgenommen wurden, führt – unabhängig davon, aus wie vielen und welchen Entitlements Lizenzen auf diesem System aktiviert wurden.

Kopieren der LockingID aus dem Lizenzmanager

Um für ein System eine Revocation anzustoßen, kann man zunächst die LockingID des Lizenzmanagers kopieren, um damit im Lizenzportal nach den aktivierten Lizenzen zu suchen.

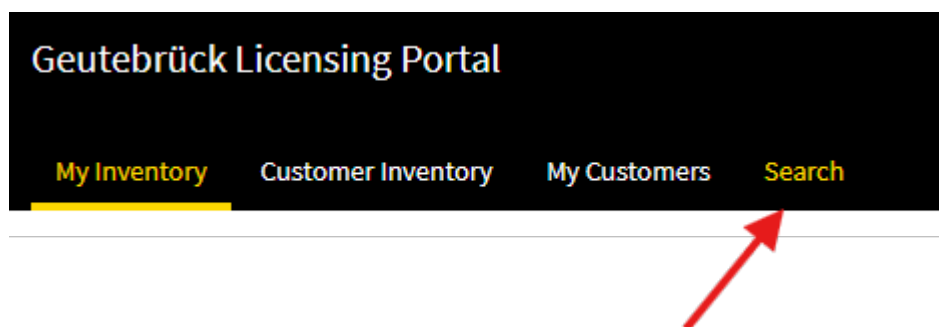

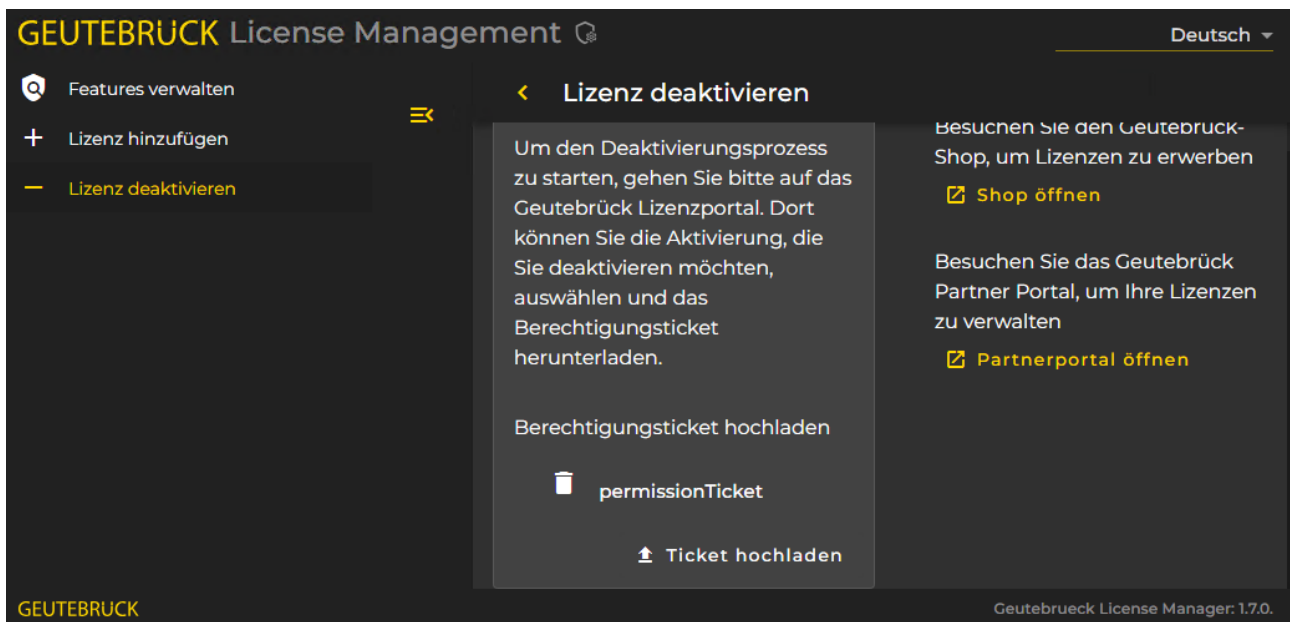

Background

Licenses that authorize the use of Geutebrück software are activated for a specific piece of hardware and can only be used on that hardware. This means that if the hardware or parts of the hardware are replaced, it may be necessary to revoke the activations for that system so that the licenses can be reactivated after the hardware has been replaced.

The Geutebrück License Manager has a LockingID that uniquely identifies the system when licenses are activated. All activations performed for this system can be found in the Geutebrück license portal using this LockingID. Activations can also be searched for using the ID of an assigned entitlement that contains the license.

- **The upgrade kit is used to upgrade Windows 10 to Windows 11.**
The upgrade kit allows you to use the latest GEUTEBRÜCK video surveillance technology and video management software.
- **Secure all setups** / passwords / databases (all data) of your system! (Windows, G-Sim, G-Core,).
GEUTEBRÜCK does not assume any liability for any costs resulting from re-parameterization of the system in the customer application.
- **After the upgrade, the Windows 10 sticker must be removed and the new Windows 11 license sticker must be affixed to the device.**
- **Please note:** After replacing the operating system/M2, it must be activated online (Internet).
This happens automatically and must then be checked in the system settings.

Procedure

Selection – LockingID vs. Entitlement

There are basically two ways to find the licenses that have been activated for the license manager of a (replacement) hardware configuration in the Geutebrück license portal in order to revoke the activation(s) there.

The first option is to search using the entitlement ID.

To do this, open the Geutebrück license manager and expand a license for which you want to revoke the activation. The Entitlement ID can be copied to the clipboard here so that it can then be pasted into the Geutebrück license portal for searching.

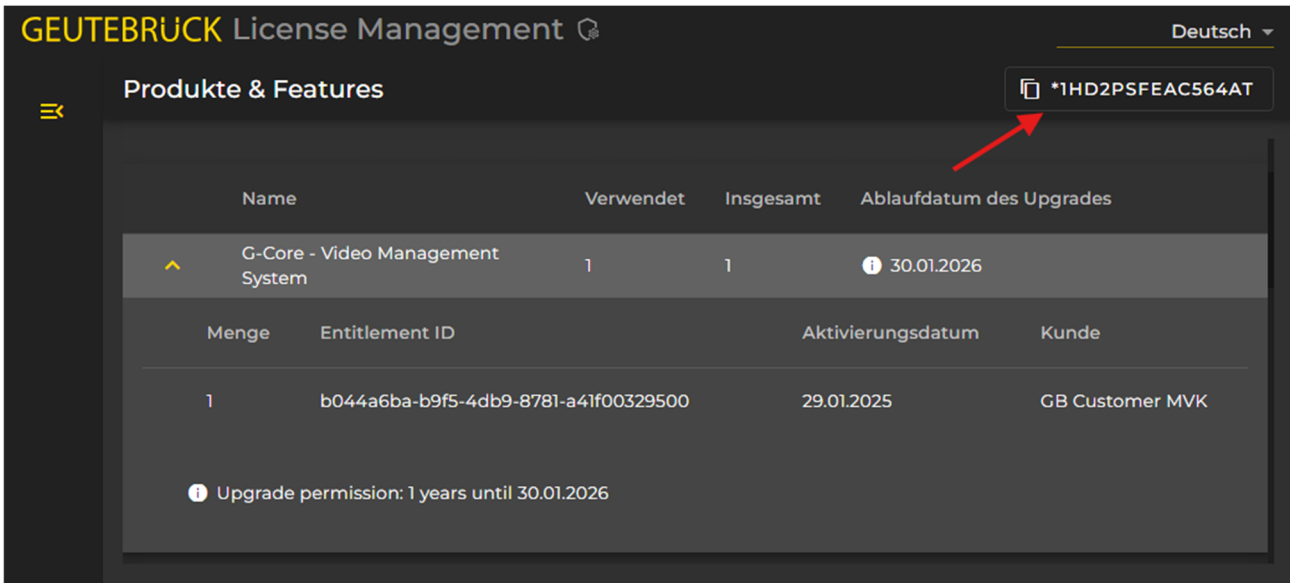

The Entitlement ID is a good option if a license manager only contains licenses for very few entitlements – ideally only one.

If the revocation must be carried out for an entire system – and not just for individual licenses – it is recommended to use the Locking ID instead of the Entitlement ID to search in the license portal.

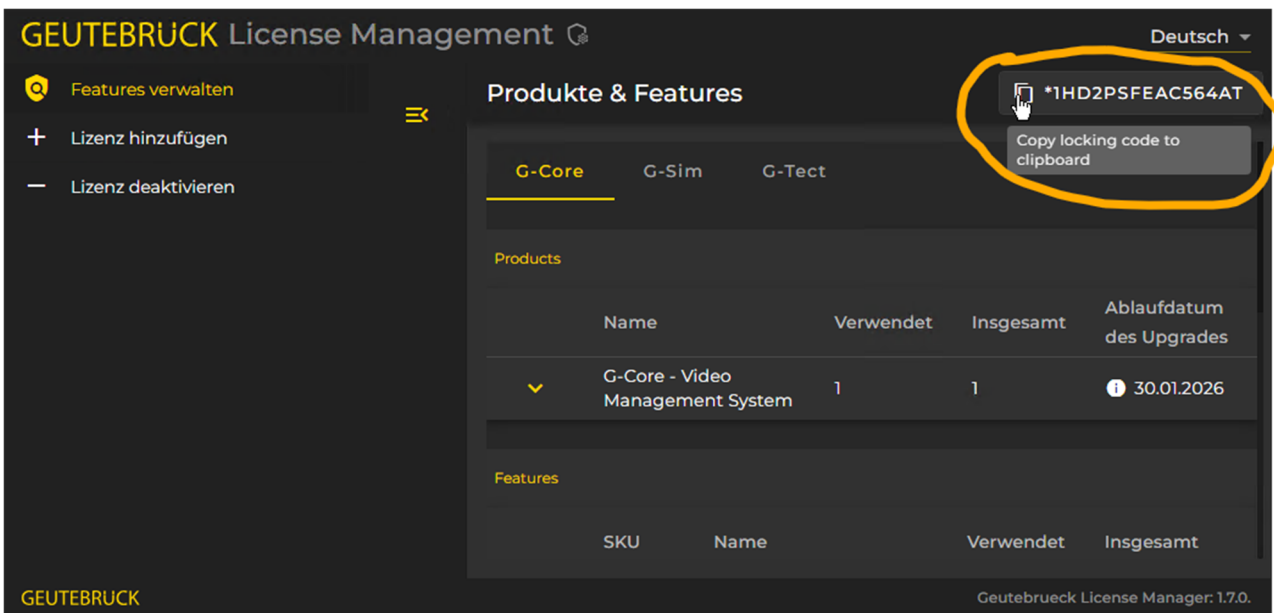

The advantage of searching using the Locking ID is that this method provides an overview of all activations made for this license manager in the license portal, regardless of how many and which entitlements licenses have been activated on this system.

Copying the Locking ID from the license manager

To initiate a revocation for a system, you can first copy the Locking ID of the license manager to search for the activated licenses in the license portal.
